Below is the background of keynote Speak, Mr. Ronald Klasko and Dr. Jim Long.

Mr. H. Ronald Klasko - H. Ronald (Ron) Klasko is a former national President and three-term General Counsel of AILA, a five-term Chairman of the EB-5 Investor Committee, and a former Chair of Business Immigration, Department of Labor and H-1B Committees. He has been chosen for *Best Lawyers in America* for 25 consecutive years, and as a most highly-regarded immigration lawyer in the world by *International Who's Who of Business Lawyers*. Ron has been invited by U.S. government agencies to participate in training (Department of State, USCIS, Department of Labor, Immigration Judges Association), and has testified before U.S. Congress on immigration issues. He currently chairs the 20-person Investor Practice Group of Klasko Immigration Law Partners, LLP and is a graduate of University of Pennsylvania School of Law and former Adjunct Professor of Immigration Law at Villanova University Law School.

Dr. Jim Long - Dr. Jim Long received his Ph.D. from the Colorado School of Mines in Golden, Colorado, in addition to a MBA from Southern Methodist University (SMU) in Dallas, Texas. Prior to receiving his Ph.D. and MBA, Dr. Long obtained his BS degree from the University of Petroleum in China. Dr. Long also worked with Electronic Data Services and SINOPEC with various management and engineering positions. Dr. Long is the managing member of the general partner of Hall Arts II Fund, LP, an EB-5 immigration fund based in Dallas, Texas. Hall Arts II Fund, LP is seeking to secure up to \$82.5 million in EB-5 capital.
